City Manager Redding updated the City Council on the following:

- Downtown Development Authority's Grand Opening of the Shops of Monticello on November 6, 2020. They would like for the City Council to distribute the Downtown Dollars for the Small Business Saturday.
- Planning Workshop information has been sent to Council to finalize the Vision and Mission Statement.
- Website Hosting Quotes are being reviewed.
- Code Enforcement- Waiting to hear from Jasper County. The City Attorney Joe Reitman will reach out to the county attorney because the County Attorney is pushing for Monticello to abolish their Ordinances. The Jasper County Board of Commissions stated that it is not something we should do because if we decide to take back over Code Enforcement, we would have to start over with our ordinances. There is a possibility that we may need to reach out to the Jasper County Board of Commissioners. A company has been contacted that can provide certified code enforcement services. They also provide a vehicle with insurance and a software

program. The person hired can start working immediately, and there are funds in the budget to cover this service for at least six months. This service will cut down on the training for an inhouse person.

- The Bonner Street Bridge Project is complete.
- Benton Tree Service has started tree limb pickups.
- Property on West Washington Street They provided an estimate to request a lien against that property.
- Street Department Truck purchased in 2019 has several issues. This truck has been at Ginn Automotive for two weeks due to a stalling motion. We have contacted the service manager about a loaner truck, but they do not have one. The general manager was contacted about getting a buyback or a remedy to the situation. He is contacting Chrysler for assistance to the service department to get the truck repaired because we have a warranty, but we do not want it to expire before they fix it. Attorney Reitman has provided information on the Lemon Laws. The general manager said he would try to get a truck for the City to use for its operations until they can find out what is going on with the truck. Today they received another code for a pedal adjustment. There is a lot going on with the truck, and we are trying to remedy the situation.
- Auditors The City of Monticello needs to put out a RFP for auditors.
- Advanced Disposal will adjust their rates by 1.7% in January 2021.
