Regular Meeting Tuesday, May 14, 2019 6:00 P.M. Minutes

Mayor Pro Tem Workman called the meeting to order. Peggy Billerman called the roll.

Agenda approval – Motion by Councilmember Murphy, seconded by Councilmember Wease, to approve the agenda. All in Favor.

Citizen Comments – Jehan El-Jourbagy proposed a bench honoring her father, Morad El-Jourbagy be placed at Westview Park. The family will bear the cost and make the arrangements for delivery. Motion by Councilmember Murphy, seconded by Councilmember Wease, to approve the bench. All in favor. Jerry Wyatt spoke again about the PCA, ethics and the cost of electricity. City Clerk will arrange a meeting with a representative of Electric Cities of Georgia if Mr. Wyatt will suggest some days and times when he could attend a meeting. Stephanie Puckett spoke against the company leasing the Cannery from the DAJC.

Zoning Public Hearing postponed from the April 9 meeting at the applicant's request. 2019Z02 filed by Jasper County and the DAJC to rezone 985 Hillsboro St., known as the Cannery, from R20 to M1 Light Industrial, to allow assembling of cabinets. Stephanie Puckett spoke against the company leasing the Cannery from the DAJC. Motion by Councilmember Thurman, seconded by Councilmember Wease, to approve the rezoning. All in favor.

ECG Pole Attachment Agreements with Verizon and Cingular - Motion by Councilmember Murphy, seconded by Councilmember Thurman, to approve the agreements. All in favor.

Springfield Baptist Church requests partial road closure for a church picnic June 1st. Motion by Councilmember Wease, seconded by Councilmember Miller, to approve the closure with JCSO approval. All in favor.

FY20 Budget and consensus to publish 5 Year History - Motion by Councilmember Miller, seconded by Councilmember Thurman, to publish the history and to make the draft budget public. All in favor.

Chamber of Commerce – Mandi Tanner reported 152 COC members and 21 Cornerstone members at this time. 1720 visitors have come into the Visitors Center this year.

Manager's Items – Moving forward with DFACS lease. Gearbox on the lime feeder at the water plant went out and had to be replaced at a cost of \$2,795. The Get Ahead House and Funderburg Park need mulch under the playground equipment. A dump truck load will be ordered.

Motion by Councilmember Thurman, seconded by Councilmember Miller, to appoint Karen Pennamon as City Clerk. All in favor.
