- 4. Ratify the Second Amendment to the Intergovernmental Agreement with Blockstream
- 5. Consider an Ordinance by the City Council of Monticello approving an Amendment to the Gas Supply Contract and Supplemental Contract between the Municipal Gas Authority and City of Monticello, Georgia, and for other purposes

**Background and Summary:** This resolution is for the governing body to accept 30% Phase I funding from the Office of the Governor of the State of Georgia. Phase I funding shall be used on eligible activities set forth in the guidelines provided by the Treasury and should be used by September 1, 2020. The U.S. Treasury has instructed that funds may not be used to fill shortfalls in government revenue to cover expenditures that would otherwise not qualify as an eligible expenditure. As Phase I funding is exhausted additional program and disbursement criteria for the remaining allocation of funds will be developed and evaluated to ensure there is flexibility to respond to the ongoing impact of COVID-19. All costs must be incurred before December 30, 2020 to qualify for the remaining 70% of the funding. COVID-19 Pandemic is considered a national emergency and awarded funding does not require a match.

7. Consider a Resolution by the City Council of the City of Monticello declaring certain city property, listed on "Exhibit A", to be surplus property and to provide for its proper disposal either by auction or other methods pursuant to the city's ordinances; and for other purposes.
