January 6, 2022 MINUTES

Members Present – Mayor Gail Harrell, Councilmembers David Wease, Cynthia Miller, Jennifer Murphy, and Larry Thurman were present.

Motion by Councilmember Murphy to add to the agenda the appointment of a part-time temporary interim City Manager, seconded by Councilmember Wease. Voting for the motion was unanimous. Motion by Councilmember Wease to appoint Peggy Billerman as interim temporary part-time City Manager effective January 7, 2022, seconded by Councilmember Miller. The motion passed 3-1 with Councilmember Thurman opposed.
