City Manager Items:

*The FoodMart on Frobel has regained its alcohol permit, certifications will be sent.

*The Percy Smith Trailer Park's position on water meters is that water meters would be free based on a letter from Tim Young. Joe Reitman says that they must pay or we would be in violation of the Georgia Gratuities Act. They have a 2" meter on the right of way and it should be used for billing. If they don't want to use the 2" meter they will have to pay tap fees at each trailer.

*Peyton Proctor, Jasper Co. Middle School Safety, has requested two yellow lines on Post Rd. *Tillman Landscaping increases fees \$1608.75.

*The company that purchased GP is using a lot of water. During the recent fire over a million gallons were used. I am asking for \$36,000 to purchase a water meter to set on the main. There is money in the budget. Motion to approve by Councilmember Wease, seconded by Councilmember Murphy. All in favor.

*Honeysuckle Road is being used by thru trucks. We will check the signage.

*Code Enforcement has 72 open cases. Court on the 18th has 10 and there are 5 on tap for 4/1/22.
