City Manager Update

City manager Sands stated Jasper County SPLOST collections ends March 31, 2024, and the Jasper County BOC is planning to place a referendum on the March 21, 2023, ballot to continue collecting the one cent tax beginning April 2021. The Jasper County BOC is trying to approve the SPLOST resolution at the December 5, 2022, meeting, and needs the Council to identify projects and pricing at the next Council meeting. GDOT TA Grant received five times as more than expected applications, they are still reviewing applications, and the final decision should be made by the end of October. She also stated Frank Dumas, facility maintenance, reached out to Mr. Wilson for the bricking repointing of City Hall and the estimated date to start is October 17, 2022. Robert approached Waymon to determine if the city would issue permission (permit) for an 8" sewer line extension to serve the part of the GAP Family

Partnership property adjacent to Piedmont Academy on Hwy 212W. This is proposed roughly 30-acre development area, with mix of retail, restaurant and office use that would generate around 3500 gallons per day of effluent. If the City grants permission the developer would incur all the costs of the proposed sewer extension and it would be built to City specs with dedication to the City and maintenance easements. Robert is requesting a written documentation confirming if the extension is possible. She briefed the Council on the ECG Rate Classification Study training offered the front office staff in November 2022 (the date is TBA) and the office would be closed for 4 hours. The Curse of Bridge Hollow will be released this Friday, October 14, 2022. The department heads and herself will review the movie to ensure that there aren't any surprises prior to the view.
