8. City Manager Update

City Manager LaThaydra provided clarification on the funding the city provides to the Monticello – Jasper County Chamber of Commerce.

The department heads have submitted budget amendments and there are more that will need to be made once the budget year is closed out.

Staff Meeting and Appreciation was originally scheduled for June 28th but has been rescheduled to July 12th. We will also have a safety meeting hosted by LGMRS to address some of the safety concerns.

We are still working with Carter & Sloope to get a plan for LAS as well as alternatives.

Amanda with Bates and Carter is looking at 4 to 6 months to complete the audit.
