David Thompson thanked the council for the project board and requested the council to repair the current sidewalks before extending them, and he stated he was opposed to the hunting on the Mine Lake property.

City Manager Sands stated the City will be closing the Funderburg Drive Park bridge until repaired due to missing railing and boards and will inform council once the City receive quotes. She contacted Georgia Department of Transportation regarding the TA Grant and is waiting for a response. Mrs. Sands expressed the city should host an event to engage with the community for Georgia Municipal Association City's Week is held on April 23rd through 29th. The city has received several questions regarding park food permits, and after seeking legal advice; non-profit, local government, churches, or 501C3 are not required to have a food permit for park reservations. As a reminder the Chinese gift exchange for Christmas will be on December 22nd at 11:30am and requested the council to participate. AT&T Fiber will be installed in the Adam McGinnis's building next to the city hall and suggested researching having it installed in the City's building. Complaints are still being made about vehicles located where they're not supposed to be so all city vehicles, except department heads will have trackers installed as well as logos.
