Pat Finger, Representative of the Concerned Citizens of Monticello, stated her concerns about the safety of the sand (playground protection surface) at the city's parks.

9. City Manager Update

City Manager Sands briefed the council on the following items:

Park: The bleachers have been ordered for Sands Drive Park and surveillance mechanism has been installed for all parks. The City of Monticello received a letter from Georgia Department of Natural Resources on inspections completed at Sands Drive and Funderburg Drive Parks, which both parks passed the inspections.

Paving Quotes: The City has only received two paving quotes from Shepherd Paving and Houston Asphalt and is still waiting for one more quote.

The city is having issues with heavy duty trucks in residential areas parking overnight and breaking up the road, so she has asked code enforcement to investigate this matter.

Zoning Committee Update: An ad has been placed in the newspaper for members and a survey will be created by the end of the week to the public.

Electric and Gas Building Update: Some change orders will be coming. GDOT has required a relocation of the water main and the septic main drain field from the original design.

Staff Training: City's staff will be receiving harassment training by LGMRS held tomorrow with two different time slots and Lunch and Learn session on team building.

RLF Committee: Pan Myer will help assist with finding a committee, reached out to Brad Hawkins with Newton Federal Bank to serve on the committee, but needs to research the term limits with DDA.

DDA Movie Night: DDA has submitted a reservation for movie nights on the square for the following dates, June 23rd, July 28th, August 25th, and Haunticello.
