# Budget Work Session/Public Hearing Minutes June 20, 2023 5:30 PM

#### Call to Order

Mayor Thurman at the Special Called Budget Work Session to order at 5:30pm.

# **Innovation & Pledge of Allegiance**

The invocation was given by Council Member Wease followed by the Pledge of Allegiance.

#### **Roll Call**

The City Clerk called the roll. Mayor Thurman, Mayor Pro Tem Currie, and Council Members Miller, Murphy, and Wease were present. Council Member Thurman was not present.

# **Council Review Fiscal Year 2024 Budget**

The City Council reviewed and discussed the fiscal year 2024 budget and made the following recommendations: reduce the DDA payments by \$800 to make the total fiscal year 2024 budget \$8,667,280.

### Public Hearing FY 2023-2024 Budget

A Public Hearing is scheduled seeking public input on the City of Monticello's FY 2023-2024 Budget and Tax Digest as proposed.

Mayor Thurman opened the floor for the public hearing at 6pm.

**Patricia Fingers**, Representative of the Concerned Citizens of Monticello, questioned the reduction in fiscal year 2024 budget from last year's budget and why the revenues and expenditures are the exact same amount.

**Roberta Anderson**, 275 Frobel Street, expressed her concerns about the city's audit not being up to date and questioned the city council on why they are cutting some departments and not others.

**Reginald Jacobs**, Pastor of St. James A.M.E. Church, questioned if the city operated without a budget in the last four years and if the citizens could have copies of the proposed budget.

**Camilla Goodrum**, 38 Rooks Lane, asked if there was a surplus in last year's budget but wasn't fulfilling citizens' requests.

**Gail Harrell**, 559 Hillsboro Street, gave an overview of the City's financial standpoint when she was in office as the Mayor and questioned the DDA director position.
